"We are excited to bring a fuel center and Caribou Coffee to this location as well as remodel several departments. Construction has begun on the new fuel center which adds convenience for guests as well as allows them to take advantage of the new MORE Fuel Rewards program. Guests can save \$0.10 per gallon for every \$100 spent on groceries. These rewards will be redeemable at the fuel center once it's complete.

Plans also include a new in-store Caribou Coffee with seating. Guests can enjoy a warm or cool beverage while shopping or grab a muffin or sandwich to go. The liquor department will be expanded to offer shoppers a larger selection. The fresh departments including produce, meat, dairy, and deli, will be updated to focus on fresh and enhance the customer's shopping experience. The exterior will be updated too, and the existing parking lot will be replaced.

The store will remain open during construction which is expected to continue through 2023. A public grand re-opening celebration will be planned for 2024.
