Cash Wise Foods Announces Grand Re-Opening in Jamestown, ND

The modern and convenient grocery store includes expanded and enhanced fresh and liquor departments plus the addition of Caribou Coffee and a fuel center.

ST. CLOUD, MN – Coborn's, Inc., the parent company of Cash Wise Foods, is excited to announce the grand re-opening of the Jamestown Cash Wise shopping campus located at 410 10th St. SE. The grocer recently completed significant enhancements to the store offering guests a larger product selection and a modern shopping experience focused on freshness and convenience.

The project began in August 2023 with the construction of a new fuel center, adding convenience for guests. The fuel center opened last fall allowing guests to take advantage of the MORE Fuel Rewards program. Guests can now save \$0.01 per gallon for every \$10 spent on groceries, plus earn fuel reward savings on items purchased as well as promotional events.

The remodel project also includes doubling the size of the liquor store to accommodate a significantly larger assortment, and the addition of a new Caribou Coffee with in-store seating, drive-thru and order-ahead capabilities. Other upgrades to the store include expanded and enhanced produce, meat, deli, bakery, and center store departments giving guests a fresher and larger product selection. The store's exterior also underwent a refresh including a new parking lot and updated signage.

In addition, Ace Hardware was expanded to the east end of the shopping campus, making this truly a destination for one-stop shopping. The hardware store opened this past spring.

"We know this project took time, and we sincerely thank our guests for their patience during the process," said the store director, Sarah O'Heron. "The store guests know and love is still here, but now with exciting enhancements that make it even better. With a fresh look and new features, we're confident these improvements will make our guests' shopping experience more enjoyable than ever."
